Subject: Regarding 'Digi-Saksham' - digital enablement program for master teachers and teachers in context of NEP as approved by the government.

Respected Sir

As per approval of the government, it is proposed to hold a program 'Digi-Saksham' for digital enablement of teachers to enhance effectiveness in blended (online and offline) teaching learning process, ongoing unique state initiative 'Har Ghar Pathshala' and in context of NEP tasks as mentioned in chapter 15 (Teacher Education) and chapter 24 (Digital education). Under this program, cadre of 1200 Master Teachers (MTs) is to be developed which will include, 350 State Resource Group Teachers (SRGs), 830 Lecturers new Computer Science (regular), 24 TTIs (Elementary and Secondary), 12 DIET Faculties (1 each from Education Technology).


These 1200 MTs will be trained in 5 cohorts, each of 240 MTs. Each MT will devote 6 hours per week and 60 hours of curriculum will be delivered in 4 Learning Cycles (LC). MTs will start facilitating curriculum for teachers after completion of LC 1, where Each MT to lead learning of 30 teachers in phase 1 - for 2 hours per week. Program aims to cover all teachers of the state in 11 phases (1st Phase - 30,000 including elementary and secondary and remaining teachers in 2nd phase). In this context, it is requested to appoint a nodal officer from your office for coordination in making this program successful.
