This may be treated as most urgent and time bound please.

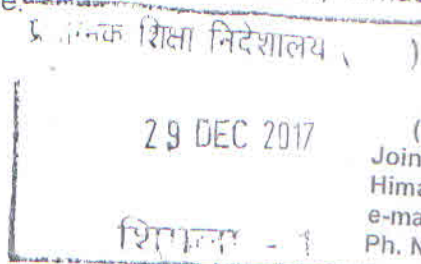

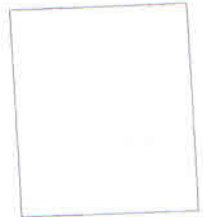
