In this regard, you are therefore, directed to appoint a Senior officer/teacher as a complaint officer, if having 100 or more persons in your office /institute.

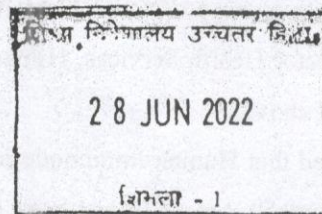
