In continuation to this Directorate letter of even number dated: 27-03-2020, 02/04/2020, 09-04-2020 and 25-04-2020 regarding deposit of school fees & funds during curfew/lockdown period.

Despite of repeated direction/reminders, some of the private school managements are sending SMS to parents of the students to deposit hiked school fees & funds during lockdown curfew in the state due to COVID-19 pandemic. Such Behaviour and action on the part of private school managements is clear cut and willful violation of "The Epidemic Disease Act"/ The Himachal Pradesh Private Educational Institutions (Regulation) Act-1997" and the directions/instructions issued from time to time by the Department of Higher Education.

In this connection, it has been brought to the notice of undersigned by the Parents of Students' studying in private schools that they are charging/collecting Fees/Funds from the students during lockdown period/curfew in the state due to COVID-19 pandemic.
