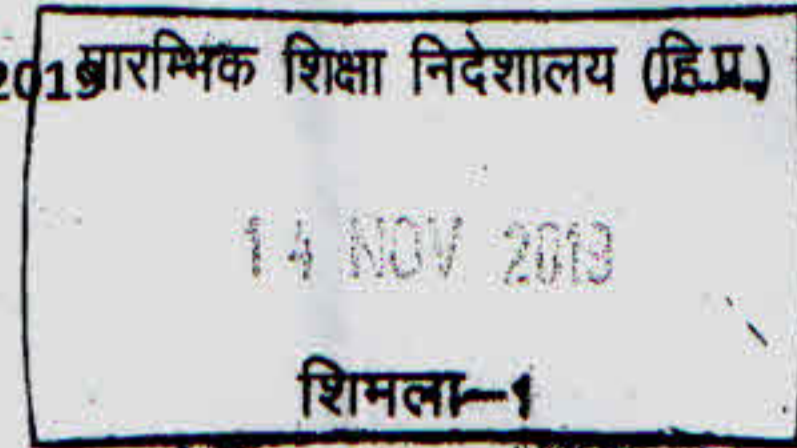

Subject: - Regarding implementation of "Pradhan Mantri Shram Yogi Maan -Dhan" Pension Scheme.

Sir/ Madam,

In continuation of this Directorate letter of even No dated 06.07.2019 vide which details guidelines regarding implementation of "Pradhan Mantri Shram Yogi Maan -Dhan Pension Scheme (PMSYM)" have been circulated to you with the direction to circulate these guidelines to all the schools and ensure to enroll **all the eligible mid day meal workers & part time workers having 18 - 40 years of age as** mandated in the above said pension scheme. The copy of the abovesaid (PMSYM) Pension Scheme may be downloaded from https://himachal.nic.in/index.php?lang=1&dpt_id=16. However, all the mid day meal workers and part time workers will be required to have mobile phone, saving bank account and Aadhar number. The eligible subscriber may visit the nearest Common Services Centres (CSV eGovernance Services India Limited (CSC SPV) including Lok Mitra kendras Sugam etc and get enrolled for PM-SYM pension scheme using Aadhar number and saving bank account/ Jan-Dhan account number on self-certification basis.

Later, facility will be provided where the subscriber can also visit the PM-SYM web portal or can download the mobile app and self-register using Aadhar number/ saving bank account/ Jan-Dhan account number on self-certification basis.

The enrolment will be carries out by all the Common Services Centres. The unorganized workers may visit their nearest CSC along with their Aadhar Card and Savings Bank account passbook/ Jandhan account and get registered themselves for the Scheme. Contribution amount for the first month shall be paid in cash for which they will be provided with a receipt.


All the branch offices of LIC, the offices of ESIC/ EPFO and all Labour offices of Central and State Governments will facilitate the unorganized workers about the Scheme, its benefits and the procedure to be followed, at their respective centers.

In view of the above, you are once again directed to send the information regarding number of mid day meal workers and part time workers enrolled under the above said PMSYM pension scheme on the format given below to this Directorate **within three days**, so that the district wise information could be submitted to the Government in time.
