As you are well aware that e-Samwad application has been developed to enable parent teacher interaction about the children's education in Himachal Pradesh. In the past, it has been used to send multiple SMSs to parents such as information SMS about Assessments, Attendance, Holidays, Homework and Meetings. Such regular communication enables the parents to be more informed of their child's progress in school and helps in improving the overall academic performance of the students.

An additional module for collecting students' attendance has been incorporated in e-Samwad through which teachers will be able to mark students' attendance directly through the application. Attendance marked through the application will allow for real-time display of data and analysis of trends across the state. This will not only enable the teachers and officers to understand the different trends in students' attendance, but will also help all at the state, district, block, school level to make data-backed decisions.
