As per the guideline regarding the Supporting documents for **various centre sponsored scholarship scheme**, the amount less than Rs. 50,000/- to be kept at institution level and more than Rs. 50,000/- may be uploaded on the portal i.e. **NSP 2.0 /hp epass portal**.

The verification of Supporting documents (for scholarships amount less than Rs. 50,000/- kept at institution level) will be done/ensure by Institution and any discrepancies/ fraudulent and wrong verification of student's document, the concerned Head of Institution and dealing will be fully responsible regarding the matter.


