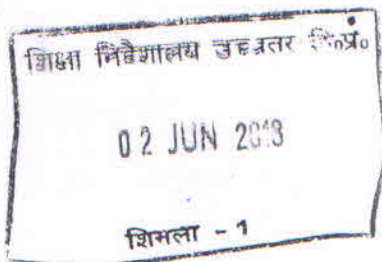

It has been observed that the provision(s) have been made in the delegation(s) circulated by this Department on 03.06.2014 for constitution of the 'Purchase Committee(s)' at departmental level/Head(s) of Department(s) level/District level. In these 'Purchase Committee(s)', the officers of SAS are to be nominated as member(s) by the Department at various levels. There is no provision for nominating the officers of Finance Department in the State Government, as member(s) in these 'Purchase Committee(s)'.

2. There are instances that the Department(s) are constituting "Purchase Committee(s)" with the title as "Representative of Secretary (Finance)" and the agenda is given in the meeting itself. Such constitution(s) of "Purchase Committee(s)" are not in accordance with the provisions of delegation dated 03.06.2014 as the representatives of Secretary (Finance) is being reflected in these Committees whereas, the officers of SAS should be nominated by designations as "representatives of Finance Department" in the purchase committees at different level(s).

3. It is, therefore, reiterated that the constitutions of "Purchase Committee(s)" by Department or organization of the Government henceforth be made strictly in accordance with the provision(s) of delegation made in the instruction of this Department circulated on 03.06.2014.
