Subject: - **Regarding purchase of Sanitary Napkin Incinerators in Private Schools of H.P. as per the directions of Hon'ble Court specification thereof.**

Memo:

In continuation of previous instructions issued from time to time regarding installation of Sanitary Incinerators in all Educational Institutions under Menstrual Hygiene Scheme pursuant to Hon'ble High Court of H.P. in CWP No. 2455/2017. You are hereby directed to issue necessary directions amongst all the **Heads of Private Schools** under your jurisdiction to purchase the Incinerators with following specifications approved by H.P. Pollution Control Board ~~through GEM~~:-

1. Ensure complete burning of Napkin
2. Ensure instant disposal in a scientific and hygienic way with fully automatic way and burn completely.
3. Burns 150 to 200 napkins/day, can be programmed for cycles/day.
4. Self-disposal by user by directly putting into the incinerator
5. Ash generation should not exceed more than 5% per napkin.
6. Ash should be collected in separate tray and ensure stack on that tray.
7. Auto power & thermal cut-off and automatic temperature maintenance should be there for safety of user.
8. Inside refractory lining should be excellent heat retention to avoid thermal loss.
9. The residence time for gaseous products in the chamber will be designed to be at least 2 seconds to ensure complete combustion.
10. The emission from incinerators shall complete the General Emission Standards mentioned under Standard for incineration section in SWM Rules 2016.
