That as per market study at this Directorate, the specification has been kept in mind of make Mega, model MP-80 UEC which is not more costly then Rs.13,500/- (FOR) which is only base for determination of minimum standard of PAS not to be considered as mandatory source of purchase. Purchase shall be made on competitive rates by way of limited tender system from the reputed suppliers/manufacturers. The items be purchased within sanctioned budget. No extra amount will be sanctioned by this department for this purpose during the current financial year.
