In continuation of this department notification number :Health-A-F(7)-1/02-I dated 9th October, 2006 the Governor, Himachal Pradesh, is pleased to revise the incentive granted under "Indira Gandhi Balika Suraksha Yojna" at Serial No. 3 iii & iv to couples adopting permanent family planning method after single girl child will be enhanced from ₹ 25, 000 to ₹ 35, 000(Thirty five thousand only) and for those adopting permanent family planning method after two girl children, it will be enhanced from ₹ 20,000 to Rs 25,000(Twenty five thousand only). The other norms/conditions shall be stands same.

The increased incentives will be applicable w.e.f. 01.01.2016.


