Subject:- Filling up of vacant posts of Class-IV employees on compassionate grounds - Extension of date.



3. Thereafter, the position prevailing prior to issuance of the Finance Department's instruction/relaxation dated 24.01.2022 shall be applicable w.e.f. 01.09.2022 in the Departments.




