On the above cited subject, it has been observed by the Ministry of Social
Justice and Empowerment, Government of India, in the PAC meeting held on 28-02-2022 that some
scholarship applications of the students are still pending at their Educational Institutions level.

lie on defaulter Educational Institution(s) to the remaining students.**
