NOTIFICATION

In exercise of the powers conferred by Section 27 of the Himachal Pradesh Private Educational Institutions (Regulation) Act, 1997, the Governor of Himachal Pradesh is pleased to insert a new condition No. 18 after existing condition No. 17 in Form-I Part-II (under Rule-3) of the HP Private Educational Institutions (Regulation) Rules- 2003 as follows: -

**“18. The disputes between parents, teachers and management should normally be resolved in the meetings of the Parents Teachers Association of the Educational Institution. In case the dispute still remains un-resolved then the aggrieved party may refer the matter to a grievance redressal committee under the chairmanship of the Deputy Commissioner of the District with Deputy Director Higher Education and Deputy Director Elementary Education as members. The Deputy Director Higher Education of the District would be the member secretary of the committee. The decision of the grievance redressal committee would be final and binding on the parties concerned.”**
