NOTIFICATION

Whereas the State Election Commission has issued election programme for the conduct of by-election to casual vacancies in Panchayati Raj institutions in the State, vide Notification No.SEC (F)1-35/2022 dated 01<sup>st</sup> April, 2022;

Therefore, the State Election Commission in exercise of the powers vested in it under Article 243K of the Constitution of India and Section 160 of the Himachal Pradesh Panchayati Raj Act, 1994, hereby directs that the Model Code of Conduct as notified by this Commission vide Notification No.SEC-16-29/2000-1-3768 dated 03<sup>rd</sup> November, 2020 shall come into force with immediate effect in the territorial jurisdiction of those Gram Panchayats, Panchayat Samiti and Zila Parishad wherein, by elections are scheduled to be held on 2<sup>nd</sup> May, 2023, till the election process is completed, as under:-

Sr. No.	Name of institution	Territorial Jurisdiction where the Model Code of Conduct is enforced
1	Gram Panchayat	Entire Gram Panchayat shall come under the Model Code of Conduct where by-elections to Pradhan, Up-Pradhan and Member are being held.
2	Panchayat Samiti	Entire Development Block shall come under the Model Code of Conduct where by-elections to Member Panchayat Samiti are being held except the territorial jurisdiction of Municipalities within Block.
3	Zila Parishad	Entire District shall come under the Model Code of Conduct where by-elections to Member Zila Parishad are being held except territorial jurisdiction of Municipalities within district.

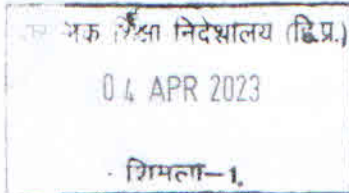
