Dear Ma'am/Sir,

As you are aware, lack of menstrual knowledge and poor access to sanitary products are some of the major causes for dropout and absenteeism among adolescent girls studying in schools. For enhancing access, retention and quality by promoting enrolment drives for girls, Department of School Education and Literacy, Ministry of Education, under the scheme of Samagra Shiksha, is providing funds to States and UT's for State specific projects for Equity including Sanitary Pad vending Machines and Incinerators.

2. In this regard, I would like to request you to direct the concerned officials to take necessary steps to create awareness amongst adolescent girls in schools about safe usage and benefits of Sanitary Napkins which would further help in increasing retention and reducing drop-out of adolescent girls in schools. Further, it may also be communicated that subsidized sanitary napkins are available at the Jan Aushadi Kendras set up by the Ministry of Chemical and Fertilisers, Government of India. The Education Department in the State may also explore the possibility to converge with Jan Aushadi Kendras in the matter.

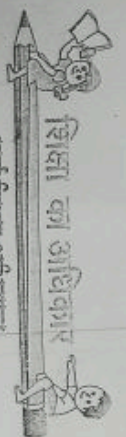
