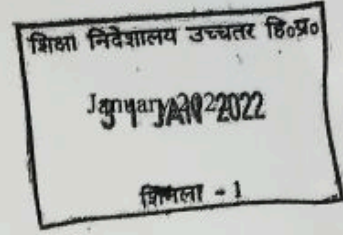


Subject:-

Regarding reopening of Schools in Himachal Pradesh.

In pursuance to letter No. Rev(DMC) (C)20-2/2020-COVID 19-IV dated 31st January, 2022, vide which the decision of the Government has conveyed that:

1. Classes from 9th to 12th are allowed to function w.e.f. 03.02.2022 in all summer closing schools including residential schools (Government/Semi Government/Private) in Himachal Pradesh. All other classes will continue to remain closed. The School administration will ensure observance of the COVID-19 SoPs and safety protocols while conducting the classes.
2. Online classes for students of 1st to 8th will continue till further order.
3. All the teachers (Summer closing schools) will attend the school w.e.f. 01-02-2022 regularly to ensure the proper sanitization and cleanliness of the school campus and classes 9th onwards will be started w.e.f. 3rd February, 2022. The School Administration is also directed to repeatedly sensitize the students for compulsory wearing of mask, hand sanitization etc. The Head of the Institution shall ensure classes in staggered manner following the SOP's to avoid congestion in order to adhere to safety guidelines and appropriate behaviour as per COVID-19 protocols.




