Subject: - Regarding reopening of Schools in Himachal Pradesh.

In Pursuance to letter No. EDN-B-B(14)-12/2018-L dated 25-09-2021 received from the Secretary (Education) to the Government of HP and Orders No. Rev(DMC) (C)20-2/2020-COVID-19 dated 24-09-2021, issued by the Revenue Department – Disaster Management Cell, on the subject cited above, vide which the decision of the Government has conveyed that :

1. Schools in Himachal Pradesh will reopen for classes 9th to 12th w.e.f. 27th September, 2021 following the Standard SOP's issued by Government of India, Ministry of Education, Department of School Education & Literacy on 05.10.2021 and by the Government of H.P./Department of Education from time to time.
2. Students of Classes 10th and 12th will attend the school on every Monday, Tuesday and Wednesday of the week.
3. Students of classes 9th & 11th will attend the school on every Thursday, Friday and Saturday of week.
4. Online classes for students of 1st to 8th will continue till further order.
5. School Administration is directed to repeatedly sensitize the students for compulsory wearing of mask, hand sanitization and maintenance of physical distancing. The Head of the Institution shall ensure classes in staggered manner following the SOP's to avoid congestion in order to adhere to safety guidelines and appropriate behavior as per COVID-19 protocols. 
