

Subject:- Regarding report of National Crime Record Bureau (NCRB) on suicide cases.

Sir,

Reference is made to Director General of Police, H.P. office D.O, letter No. 3627-34 dated 17.12.2021 on the subject cited above

In this regards, it is intimated that as per the NCRB report on suicide cases in Himachal Pradesh during 2020, it has been observed that suicide cases are on the rise in the State. A record of the suicide cases are maintained by each Police Station within jurisdiction in H.P. u/s 174 Cr.P.C. & u/s 306 I.P.C. since 1st January 2021. On the analysis of suicide cases during the period from 1st January, 2021 to 30th September, 2021, it is found that in District Una, P.S. Gagret and P.S. Sadar Una recorded 14 suicide cases each under section 174 Cr.P.C. (Part-I).

The most common factor that can influence a person's decision to commit suicide is severe depression. Depression can make people feel great emotional pain and loss of hope, making them incapable to see alternate view to relieve the pain other than ending their own life.

Therefore, in view of the forgoing facts and circumstances, you are requested to take adequate steps to address the increasing incidents of suicide at your level with the help of Departments of Health, Panchayati Raj & Rural Development and NCC, functioning in the District and Sub Divisions.
