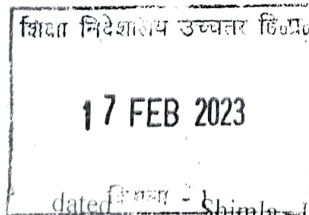

All educational institutions shall display "Tobacco Free Educational Institution" signage as specified in **Annexure-II** in the premises of the Educational Institution and a "Tobacco Free Area" signage as specified in **Annexure-III** outside the Educational Institution. The signage could be in the form of boards or wall paints. All Heads of educational institution shall ensure that no tobacco products are sold inside the premises and in an area within 100 yards from the premises. Any violation should be reported to the local Administration and National Quitline at 1800-11-2356 immediately.

As per aforementioned, you are directed to issue necessary directions to all the establishment working under your control to take further necessary action in the matter.


