Subject: Safety of the School Buses-Adherence of Guidelines thereof.

Sir/Madam,

In continuation to this office letter of even No.6368-77 dated 26.04.2022 (copy enclosed), on the subject cited above, vide which you were requested to ensure the provisions of Rule 73A of Himachal Pradesh Motor Vehicles Rules, 1999 and also the vehicles/ buses must have valid fitness, Insurance, Route Permit, Pollution Under Control Certificate and authorized driver having valid driving license.


During surprise checking of vehicles it has been noticed that some educational vehicles/buses are still plying in violation of the provisions of Rule 73A of Himachal Pradesh Motor Vehicles Rules, 1999 and Motor Vehicles Act, 1988 and are being challaned and penalized for their respective violations/offences committed.

You are, therefore, hereby again directed to ensure all the provisions of the Rule 73A of Himachal Pradesh Motor Vehicles Rules, 1999 and all the vehicles/buses must have valid documents, failing which strict action with regard to impounding of vehicles/buses and cancellation of route permits will be initiated as per the provisions of Motor Vehicles Act, 1988 accordingly.

This may be treated as most urgent.
